Connor Dupre nominated as Committee member for the Art Dept & Set Dec rep by Mike Collier-Prickett. Seconded by Colin McNab and passed by members present.

8. BBC Freelance Rate Card

The updated rate card has been submitted to the BBC by Paul following feedback and waiting for agreement. This is for BBC Scotland output, and not BBC Studios or BBC Studiowork productions who operate separately.

9. QTV Rate Card

There has been an informal agreement with QTV re a ratecard. This is due to expire and Paul McManus is asking for feedback re pay rates with QTV, particularly with Sound Assistants and those working on their streaming output. Please get in touch with Paul on PMcmanus@bectu.org.uk.

11. Any Other Business/questions

- a. **Government investigations.** There are two separate government investigations in relation to Anti-Competitive behaviour within the industry. Links:

These are in the review stage and there should be an update in March 2024. Paul McManus noted the OB/Sports output that could be affected by this investigation. However, if anyone has any problems please do get in touch with

the union at the time, as no issues should be put on hold due to the investigations.

- b. Question re BECTU/PACT updates. There is a focus group with reps from both parties that have produced joint guidance, they will meet this week (w/c 15th Jan) to build upon the document published in Dec 2023. BECTU and PACT entered mediation in the first half of last year, the results arising from the changes in the BECTU/PACT agreement that refer to "early calls" and "broken turnaround" were "inconclusive". Further discussions will continue in this respect. Mike C-P is part of this group so please let him know any feedback you have, and to see the evidence pack that the Hair and Make Up branch have been putting together regarding early call in particular.
- c. Updates from Paul McManus BBC Studioworks redundancies updates. BBC Studioworks operate out of Kelvinhall, PQ, and other studios across the UK. There is due to be a round of redundances for their staff members due to the lack of work (strikes and unscripted commissioning pause part of this). They've closed two studios in England one for the RACI issues, and one due to lack of work. Kelvinhall in particular is not expecting commissions until 2025.
- d. Updates from Paul McManus STV Staff wages increase. BECTU has been part of the negotiations for a raise in wages alongside the NUJ for the STV group. BECTU members have accepted the last offer, but NUJ members have rejected it. Negotiations are ongoing. It's noted that STV Studios Production Company have had no new commissions in the past year. A quarter of the STV group's income has come from the newly acquired Greenbird https://greenbird.tv/partners/ (Group of production labels) which is a shift in finances. If anyone had any feedback re STV please discuss with Paul McManus or your committee members.
- e. **Question re Unscripted Rate Card.** Last year there was a survey conduction across all job roles in Unscripted productions to generate an updated Rate Card. CSL apologies for the lack of rate card, this has been due to SFB committee changes, an awareness of a lack of work within the Unscripted work force and personal delays. CSL has been discussing rates and ratecards across the industry with the Unscripted Branch of BECTU and the aim is to issue a joint rate card asap.
 - Please ensure you keep your rates and report any production companies capitalising on the lack of work to reduce rates. CSL also reminded members (unless you are a ltd co) all rates are to be exclusive of holiday as per the legal requirements, and please report any production companies who try and wrap holiday % into your rates.
- f. Updates from the committee BECTU Vision Website Facebook Twitter/X. We're blessed in Scotland to have BECTU vision who run training and socials

regularly. Please use them and get in touch if you have any training recommendations, or are unable to attend any training but would be keen to see the recording (if applicable) or sign up for future training. During conference in the summer BECTU Vision presented their ways of working to RPD and is seen as quite the jewel in Scotland's crown. **Please use it!** We thank the team at Vision for all their hard work.

- Q when is the next First Aider Training? There was a round of First Aider training in December, and it runs regularly so please keep an eye on emails and social media for updates.
- g. **Question re NEC reps changes.** There have been a number of resignations at the NEC by BECTU reps are BECTU reps to be replaced? There have been resignations, and those reps have been replaced by BECTU reps.
